<u>ORDER</u>

Vide the reference cited as 1 above, the Institute had issued notification for the external recruitment of 14 posts (13 Group A Scientific & Technical (Academic) posts and 1 Non-Academic post).

Based on the direction from the Department of Science & Technology (DST) (ref:2), the Institute had postponed the written tests and Senior Staff Selection Committee (SSSC) interviews to all Group A Scientific & Technical (Academic) posts against the referred notification, until receipt of further directions (ref:3).

Vide the reference cited as 4 above, the Parliament, by the Central Educational Institutions (Reservation in Teachers' Cadre) Act, 2019 provide for reservation in appointments by direct recruitment for persons belonging to the Scheduled Castes (SC), the Scheduled Tribes (ST), the Socially and Educationally Backward Classes (SEBC) and the Economically Weaker Sections (EWS), to teachers' cadre in certain Central Educational Institutions, as defined in Section 2 (c) of the Act.

Vide the reference cited as 5 and 6 above, the Institute Body (IB) and the Governing Body (GB) have noted that the Central Educational Institutions (Reservation in Teachers' Cadre) Act, January2019 applies to all Group a Academic posts and to all Educational Institutions including

institutions of National Importance, except those Institutions listed in the Schedule under Section 4 (1) of the Act and have resolved to introduce reservation in all cadres of Scientific and Technical (Academic) posts after duly incorporating suitable provisions in the Regulations of the Institute with immediate effect.

In view of the above and as directed by the IB and GB, the referred External Recruitment Notification pertaining to 13 Group A Scientific & Technical (Academic) posts(dated 28.11.2018) stands cancelled. Fresh notification will be issued after drawing up reservation rosters as per rules.
