Bid Corrigendum

Following terms and conditions supersede all existing "Buyer added Bid Specific Terms and conditions" given in the bid document or any previous corrigendum. Prospective bidders are advised to bid as per following Terms and Conditions:

Buyer Added Bid Specific Additional Terms and Conditions

- 1. Buyer Added text based ATC clauses
- Bidders shall quote only those products in the bid which are not obsolete in the market and has at least 1 0 years' residual market life i.e. the offered product shall not be declared end-of-life by the OEM before th is period.
- 2. The installation should be supported with spares for a minimum period of 10 years after successful install ation and commissioning. "All the spares and consumables required for the equipment should be made av ailable through GeM throughout the agreed supporting period". (A line of confirmation should be submitte d along with the bid document.)
- 3. Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any respons ibility in this regards. Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.
- 4. **Compliance Sheet and Brochure** of the product(s) offered in the bid, are to be uploaded along with th e bid documents. In case of any unexplained mismatch of technical parameters, the bid is liable for rejecti on.
- 5. **Experience**: The Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufact ured and supplied same or similar Category Products to any Central / State Govt. Organization / PSU / Pub lic Listed Company for **3 years** before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the year. In case of bunch bids, the primary product having highest value should meet this criterion.
- 6. **Scope of Supply** (Bid price to include all cost components): Supply Installation Testing Commissioning of Goods and Training of operators and providing Statutory Clearances required (if any) Installation, Com missioning, Testing, Configuration, Training (if any whichever is applicable as per scope of supply) is to b e carried out by OEM / OEM Certified resource or OEM authorised Reseller at consignee location free of co st. The payment will be released only thereafter.
- 7. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buy er.
- 8. Participating bidders should submit **OEM Authorization Certificate** along with the bid documents as p er the format given in Buyer uploaded ATC document.
- 9. Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy a vailable to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, i f: (i) The Seller fails to comply with any material term of the Contract. (ii) The Seller informs Buyer of its in ability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability o therwise becomes apparent. (iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly. (iv) Th e Seller becomes bankrupt or goes into liquidation. (v) The Seller makes a general assignment for the ben

efit of creditors. (vi) A receiver is appointed for any substantial property owned by the Seller. (vii) The Sell er has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

- 10. In case of imported products, OEM or Authorized Seller of OEM should have a registered office in India to provide after sales service support in India. The certificate to this effect should be submitted.
- 11. Service & Support: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). If service centre is not already there at the time of bidding, successful bidder / OEM shall have to establish one with in 30 days of award of contract. Payment shall be released only after submission of documentary evidenc e of having Functional Service Centre. BIDDER/OEM must have Dedicated/toll Free Telephone No. for Servi ce Support and provide Escalation Matrix of Telephone Numbers for Service Support.
- 12. **Warranty** period of the supplied products shall be a minimum of **3 Years** from the date of final accepta nce of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at th e time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break do wn during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of S ervice Centres near consignee destinations are to be uploaded along with the bid.
- 13. The bidder should submit a declaration confirming that the Product Cost/Total Cost does not include warr anty charges other than OEM Warranty. If any charges claimed by the bidder towards Three Years warran ty which is included in the Product Cost / Total Cost, the same shall be mentioned in the declaration form. Aforesaid declaration should be submitted along with the technical bid. The warranty (3 years) sought for the equipment is free warranty without any additional cost towards extended warranty and if any warrant y cost is included in the equipment cost for complying with the tender condition, the same shall not be co nsidered for arriving CAMC value. The split-up of warranty cost (if any included in product cost) shall be pr ovided (year wise) by the bidder in the financial document sought for. The proforma is available in the Buy er uploaded ATC document.
- 14. Successful bidder will have to ensure that adequate number of dedicated technical service personals/eng ineers are designated/deployed for attending to the Service Request in a time bound manner and for ensu ring Timely Servicing/rectification of defects during warranty period, as per Service level agreement indic ated in the relevant clause of the bid. After having been notified of the defects/service requirement during warranty period, Seller has to complete the required Service/Rectification within 3 days' time limit. If the Seller fails to complete service/rectification with defined time limit, a penalty of 0.5% of Unit Price of the p roduct shall be charged as penalty for each week of delay from the seller. Seller can deposit the penalty w ith the Buyer directly else the Buyer shall have a right to recover all such penalty amount from the Perfor mance Security (PBG). Cumulative Penalty cannot exceed more than 10% of the total contract value after which the Buyer shall have the right to get the service/rectification done from alternate sources at the risk and cost of the Seller besides forfeiture of PBG. Seller shall be liable to reimburse the cost of such service/ rectification to the Buyer.
- 15. Performance (during Warranty period): The time spent on the repair work will be added to the warranty period of the equipment.
- 16. Comprehensive Annual Maintenance Contract (CAMC): The maximum permissible CAMC charges f or each year after warranty period is 3 to 5% of the cost of the equipment. This CAMC charges at Net Pres ent Value will be taken into account for arriving the lowest responsive bidder. However, the actual CAMC value year-wise (excluding GST) has to be given separately in the format attached and uploaded in the Fi nancial document sought for. The 'cost of the equipment for CAMC calculation' has to be used for ca lculating the actual CAMC value. The rate percentage of CAMC quoted in the bid has to be taken into account for arriving the actual CAMC value. The 'cost of the equipment for CAMC calculation' shall not in clude additional warranty cost (if any) as stated in Sl.No.13 of ATC, cost towards Installation, Commissioni ng and Testing (other than the ICT cost subsumed in the original value of the equipment by the OEM), cos t of transportation, any specific excluded items from CAMC as per the tender terms and also GST of the equipment.
- 17. Annual Maintenance Contract (AMC) Labour: The Labour AMC charges shall be maximum 2.5% 'cos t of the equipment for AMC calculation'. The actual Labour AMC value year-wise (excluding GST) has to be given separately in the format attached and uploaded in the Financial document sought for. The 'co st of the equipment for AMC calculation' shall not include additional warranty cost (if any), cost towa

rds Installation, Commissioning and Testing (other than the ICT cost subsumed in the original value of the equipment by the OEM), cost of transportation, any specific excluded items from Labour AMC as per the t ender terms and also GST of the equipment.

- 18. The successful bidder shall enter into CAMC/AMC as chosen by SCTIMST, 3 (three) months prior to the completion of warranty period. The CAMC/AMC will commence after the date of expiry of warranty period from the date specified in the work order and agreement executed in this regard, which will be treated as the first year of CAMC/AMC.
- 19. Performance (during CAMC period): Uptime means 95 percent of total days in a year during which the eq uipment remains functional. Down time means any shortage in achieving the up-time. Down time attracts penalty.
- 20. Penalty during AMC/CAMC period will be applicable as per prevailing Rules of SCTIMST as amended from time to time.
- 21. The seller shall enclose copies of Purchase Orders for the supply of Flow Cytometer issued by National Ins titutes/Universities and Performance Certificates along with technical bid documents.
- 22. List of Essential Spares & Consumables: If the equipment contains any essential spares and consum ables, the price shall be frozen for minimum 3 years after warranty period. The price of the spares and co nsumables should be submitted separately by the successful bidder in the financial document sought for by the buyer. The format is available in the Buyer uploaded ATC document.
- 23. If the item involves software, the successful bidder should obtain software license in the name of 'Director, SCTIMST' and the paper license / email license to be transferred to the name of Institute.
- 24. Malicious Code Certificate: The seller should upload following certificate in the bid:
 - a. This is to certify that the Hardware and the Software being offered, as part of the contract, d oes not contain Embedded Malicious code that would activate procedures to: (i) Inhibit the d esires and designed function of the equipment, (ii) Cause physical damage to the user or equ ipment during the exploitation, (iii) Tap information resident or transient in the equipment/net work.
 - b. The firm will be considered to be in breach of the procurement contract, in case physical da mage, loss of information or infringements related to copyright and Intellectual Property Right (IPRs) are caused due to activation of any such malicious code in embedded software.
- 25. **Performance Bank Guarantee**: The successful bidder should furnish a performance guarantee/securit y deposit @ 3 percent of purchase order value for a period of 60 days beyond the completion of all contra ctual obligations of the supplier including warranty. Besides ePBG, PBG can also be submitted in the form of Bank Guarantee, FD Receipts pledged in the name of Director, SCTIMST or Account Payee Demand Draf t drawn from a nationalized bank favoring The Director, SCTIMST payable at Thiruvananthapuram. The PB G format is shown in the Buyer uploaded ATC Document. Hard copies of PBG in original should reach the buyer within 15 days of award of contract.
- 26. Earnest Money Deposit (EMD): EMD can be submitted in the form of Account Payee Demand Draft dr awn in any a nationalized bank favoring The Director, SCTIMST payable at Thiruvananthapuram. The hard copy of EMD should reach the office of "The Sr. Purchase & Stores Officer, Biomedical Technology Wing, S CTIMST, Satelmond Palace, Poojappura, Thiruvananthapuram, Kerala - 695012" within 5 working days fro m the closing date of the bid failing which the bid will summarily be rejected.
- 27. **Restrictions under Rule 144 (xi) of GFR 2017**: Any bidder from a country which shares a land borde r with India will be eligible to participate in this bid only if the bidder is registered with the Competent Aut hority in accordance with restrictions under Rule 144 (xi) of the General Financial Rules (GFRs) 2017 as a mended from time to time. The bidders shall enclose the following certificate along with the bid document s.

"I have read the clause regarding restrictions on procurement from a bidder of a country which shares a I and border with India; I certify that this vendor/bidder is not from such a country or, if from such a country , has been registered with the Competent Authority. I hereby certify that this vendor/bidder fulfills all requ irements in this regard and is eligible to be considered for procurement from GeM. [Where applicable, evi dence of valid registration by the Competent Authority shall be attached]."

28. Liquidated Damages: If the supplier fails to deliver or install/commission any or all of the goods or fails

to perform the services within the time frame(s) incorporated in the Purchase Order/GeM Contract, the Bu yer shall, without prejudice to other rights and remedies available to the Buyer under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to 0.5% per week of delay or part thereo f on delayed supply of goods, installation, commissioning and/or services until actual delivery or performa nce subject to a maximum of 10% of the contract price. Once the maximum is reached, Buyer may consid er termination of the contract.

- 29. If any delay by the supplier in maintaining its contractual obligations towards delivery of goods and perfo rmance of services shall render the supplier liable to any or all of the following sanctions: (a) Imposition of liquidated damages, (b) Forfeiture of its Performance Security and (c) Termination of the Contract for defa ult
- 30. Bidders must ensure that only the concerned document is uploaded in a particular field for document upl oad. Uploading the same document in multiple fields should be avoided.
- 31. Bidder's offer is liable to be rejected if they do not upload any of the certificates/ documents sought in th e Bid document, ATC and Corrigendum if any.

- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.

14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM.
